

Terms of Purchase Agreement

Please take the time to thoroughly read the terms of this sales agreement and contact Tunie's Siberians if you have any questions.

- Tunie's Siberians requires a \$200 non-refundable deposit for your place on our waiting list. Your deposit amount will go towards your purchase price which shall remain in effect for one year. After one year on the waiting list, the buyer pays the kitten prices currently in effect. This applies to purchases made on or after 1/1/24. As is the policy with other catteries, Tunies reserves the right of first choice.
- Once you are placed on our waiting list and we have a kitten available, we will notify you and you will then have 48 hours to accept or decline. If you decline the available kitten or fail to respond within 48 hours (which will be considered the same as declining); you will retain your same position on the waiting list. If you choose to decline, you may decline on up to two litters only. After you have declined two litters, Tunie's Siberians will have the right to choose the appropriate kitten for you. If you refuse the kitten that was selected for you by Tunie's Siberians, you will be removed from the waiting list and forfeit your \$200.00 deposit.
- Any cat or kitten purchased from Tunie's Siberians must be picked up on or before the scheduled pickup date or the buyer will incur a boarding charge of \$15 per day beginning with the first day after the scheduled pickup date.
- Tunie's kittens start their lives in our family. They are our pets, we have the right to refuse to sell to anyone we that feel would not be able to keep and provide an appropriate home for our kittens.
- The Buyer must agree to take excellent care of their kitten and always provide veterinary care when needed in case of illness or injury and as a preventative to disease. Please bring your new kitten to the vet within seven days of bringing it home.
- Tunie's will accept a kitten return due to an allergy within 7 days from the date of purchase. The purchase price will be refunded minus any original deposit. The buyer may not have any other pets on the premises for this to be valid. All kittens returning to our cattery must have a Health Certificate from a licensed veterinarian issued no more than two days prior to their return if more than three days has lapsed since the purchase.
- Kittens purchased from Tunie's Siberians must be spayed or neutered within four to eight months of birth. Registration papers will be only issued when a copy of a receipt from a licensed veterinarian indicating the animal has been spayed or neutered is received by Tunie's Siberians.

- Tunie's Siberians guarantees kittens from genetic defects for one year, if that said defect is evidenced in an autopsy report. Tunie's will replace that kitten with another of the same type(pet/breed/show). No cash refunds will be given.
- If for any reason the buyer of a Tunie's Siberian kitten/cat no longer wants to keep or can no longer care for the kitten/cat (including the sale or gifting of a kitten/cat by the buyer), Tunie's Siberians will be notified immediately and granted the right of first refusal. No cash refunds of deposits or purchase price will be given.
- The buyer agrees that if any of the terms of this agreement are violated, breeder may reclaim this kitten without refund of purchase price. The buyer agrees to pay all court costs if this agreement is litigated, and that any suits shall be filed and tried in Minnesota under the laws of the State of Minnesota.
